The required minimum of ECTS has to be fixed 60.</p> <p>A.3 The conferred titles will be double-title. In the statutory <b>European Diploma Supplement</b> will be figured, besides the passed program and the recognized ECTS, the name of the corresponding institution and of the title which this institution awards.</p> <p>A.4 EMPPI manages the matriculation for the ADEMS or Doctorate Programs and will refer a copy of the student records to UCM with origins in and ascribed to this university, as well as to the other Institutions of the Consortium who receive students.</p>	

## B. Fellowship Award Program

B.1 UCM will participate in the selection of candidates for pre- and postdoctoral scholarships in terms of the **Announcement** and of the **Charter of Research Fellowships** which has to be fixed.

B.2 UCM will negotiate **Externally Funded Fellowships** with the corresponding **Socrates-Erasmus National Agency**, as well as with other public and private Institutions of its country.

B.3 EMPPI will report to UCM about any offers of the European or Non-European Area to which they can apply for.
